2. INSURANCE - All Vendors must have commercial general liability insurance of ONE MILLION DOLLARS, and submit an insurance certificate or certified copy of the policy. This certificate must identify "Oak Leaf Productions" as additional named insured, but only with respect to your business operations during the 2012 Show. Show insurance can be purchased for a very reasonable price, a link to an online order form will be available from our website.

3. INDEMNIFICATION: The Vendor shall indemnify The Show and its Directors, Officers, Employees, and volunteers from all losses, claims, costs and liabilities which may arise directly or indirectly, as a result of the granting of this license. The Vendor shall be solely responsible for all acts or omissions due to or caused by any person at any time while occupying the Licensed Area.

4. NO SUBLET: The Vendor may not, under any circumstances, assign or sublet any or all of the Licensed Area under the terms of the license agreement.

5. SHOW HOURS: Friday 11-5, Saturday & Sunday 10-5.

6. SETUP HOURS: Thursday 10-8, Friday 9:00 am - 10:30 am. Setup is not allowed to take place before you register with show management.

NOTE: Drive Through Setup on Friday will NOT be allowed. Exhibitors will be required to use man doors at the side of the building. Airplane hanger door at the back of the building will not be allowed on Friday setup.
